ABSTRAK

Tujuan Penelitian

Fasilitas umum yang paling tidak patuh protokol kesehatan menurut Satgas Covid-19 Nasional yaitu restoran. Tujuan penelitian ini untuk mengetahui faktor yang berhubungan dengan perilaku penerapan protokol kesehatan pada pengunjung *food court* di Kota Pekanbaru.

Metode

Jenis penelitian kuantitatif dengan desain *cross sectional*, dilakukan pada Januari-Juli 2022. Variabel independen penelitian ini yaitu persepsi, ketersediaan fasilitas, dan kinerja Satgas Covid-19, sedangkan variabel dependennya perilaku penerapan protokol kesehatan. Penelitian ini dilakukan di empat *food court* di Kota Pekanbaru. Sampel berjumlah 105 orang dengan teknik *block random sampling*. Pengolahan data menggunakan analisis univariat, bivariat, dan multivariat.

Hasil

Perilaku penerapan protokol kesehatan pengunjung *food court* baik sebanyak 57,1%, persepsi positif 61%, ketersediaan fasilitas tersedia 62,9%, serta kinerja Satgas Covid-19 baik 60%. Variabel yang berhubungan dengan perilaku penerapan protokol kesehatan yaitu persepsi, ketersediaan fasilitas, dan kinerja Satgas Covid-19. Ketersediaan fasilitas merupakan variabel yang dominan berhubungan dengan perilaku penerapan protokol kesehatan.

Kesimpulan

Variabel yang berhubungan dengan perilaku penerapan protokol kesehatan yaitu persepsi, ketersediaan fasilitas, dan kinerja Satgas Covid-19. Variabel yang dominan berhubungan dengan perilaku penerapan protokol kesehatan yaitu ketersediaan fasilitas. Diharapkan pengelola *food court* menerapkan sistem satu pintu masuk untuk memastikan setiap pengunjung dapat mengakses fasilitas *hand hygiene* dan skrining, serta memberikan jarak antara meja pengunjung.

ABSTRACT

Objective

Public facilities that the most non-compliance with health protocols according to the National Covid-19 Task Force are restaurants. The purpose of this study was to determine the factors related to the behavior of implementing health protocols on food court visitors in Pekanbaru City.

Method

This type of research is quantitative with a cross-sectional design, conducted in January-July 2022. The independent variabel is perception, availability of facilities, and performance of the Covid-19 Task Force, dependent variabel is the behavior of implementing health protocols. The research was conducted in four food courts in Pekanbaru City. The sample is 105 people with block random sampling. Data processing used univariate, bivariate, and multivariate analysis.

Result

Behavior of implementing health protocols for food court visitor in good 57.1%, perception in positive 61%, availability of facilities in available 62.9%, and performance of the Covid-19 Task Force in good 60%. Variables related to the behavior of implementing health protocols are perception, availability of facilities, and performance of the Covid-19 Task Force. The availability of facilities is the dominant variable related to the behavior implementing health protocols

Conclusion

Variables related to the behavior of implementing health protocols are perception, availability of facilities, and performance of the Covid-19 Task Force. The dominant factor related is availability of facilities. It is hoped that the food court manager can implement a one gate system to ensure that every visitors can access hand hygiene and screening facilities, and provide distance between visitor tables.
