## **ABSTRAK**

### **Tujuan Penelitian**

Salah satu syarat puskesmas sebagai pelayanan kesehatan yang bermutu adalah memiliki ketersediaan obat yang cukup. Pada Bulan Januari 2021, Puskesmas Bungus mengalami kekosongan obat sebesar 48%. Tujuan penelitian untuk menganalisis perencanaan logistik obat di Puskesmas Bungus pada tahun 2021 ditinjau dari tahapan yang sesuai dengan pedoman teknis pengadaan obat publik dan perbekalan kesehatan (Depkes RI).

### **Metode**

Jenis penelitian adalah kualitatif. Penelitian dilaksanakan Bulan Februari -Juli 2022. Informan ditentukan dengan teknik *purposive sampling* terdiri dari 6 orang. Metode pengumpulan data dengan wawancara mendalam, observasi lapangan dan telaah dokumen. Analisis data dengan matriks triangulasi metode dan sumber untuk menghindari bias dan menjaga validitas data.

### **Hasil**

Proses perencanaan logistik obat puskesmas belum sesuai pedoman Depkes RI. Pelatihan hanya diikuti Kepala Gudang Obat Puskesmas. Permasalahan yang ditemui adalah petugas perencana obat belum memiliki pengetahuan yang cukup terhadap perencanaan obat dan permintaan obat puskesmas belum sesuai dengan ketersediaan obat Instalasi Farmasi Dinas Kesehatan.

### **Kesimpulan**

Perencana logistik obat puskesmas belum memiliki pengetahuan yang cukup dalam perencanaan obat, sehingga perencanaan belum sesuai pedoman Depkes. Disarankan Instalasi Farmasi Kota dapat mengadakan pelatihan untuk petugas perencana obat puskesmas agar memiliki pengetahuan yang baik dalam perencanaan logistik obat.

**ABSTRACT**

**Objective**

One of the requirements for a health care center as a quality public health service is have sufficient drug availability. In January 2021, Bungus Health Care Center experienced a drug vacancy of 48%. The purpose of study is to analyze drug logistics planning at Bungus Health Care Center in 2021 in terms of the following stages in accordance with technical guidelines for the procurement of public drugs and health supplies (Depkes RI).

**Method**

The research design is qualitative. This research was conducted in February-July 2022. Informants were determined using the Purposive Sampling technique which consisted of 6 people. Method data collection is by in-depth interviews, field observations, and research document. Data analysis with triangulation matrix method to avoid bias data and maintain data validity.

**Result**

The drug logistics planning process at the Health Care Center has not been in accordance with the Indonesian Ministry of Health guidelines. The training is only carried out by Head of the Health Care Center Drug Warehouse. Problems encountered are drug planning officers at the Health Care Center who do not have sufficient knowledge of drug planning and demand for medicines at the Health Care Center are not in accordance with availability of drugs in the community.

**Conclusion**

Health Care Center drug logistics planning officers do not have sufficient knowledge to do drug planning so that planning is not in accordance with the guidelines of the Indonesian Ministry of Health. It is suggested that the City Pharmacy Installation can conduct training for drug planning officers Health Care Center to have good knowledge in planning drug logistics.
