ABSTRAK

Tujuan

Ketepatan identifikasi pasien merupakan sasaran keselamatan pasien pertama sehingga perlu identifikasi pasien yang tepat untuk meminimalkan terjadi kesalahan. Namun, pelaksanaan identifikasi pasien belum optimal di RSUD Lubuk Sikaping. Penelitian ini bertujuan untuk menganalisis pelaksanaan ketepatan identifikasi pasien sesuai SOP oleh perawat pelaksana di ruang rawat inap RSUD Lubuk Sikaping.

Metode

Penelitian ini menggunakan metode campuran (*mixed method*) dengan model *concurrent embedded* dilakukan Bulan Juni 2021-April 2022. Jumlah sampel pada penelitian kuantitatif sebanyak 40 responden. Penelitian kualitatif dilakukan kepada 22 informan secara *purposive sampling*. Pengumpulan data dengan wawancara mendalam, observasi, dan telaah dokumen.

Hasil

Hasil penelitian kuantitatif pelaksanaan ketepatan identifikasi pasien sesuai SOP (60%), pengetahuan perawat pelaksana secara keseluruhan kategori baik (90%). Terdapat hubungan antara umur perawat pelaksana dengan ketepatan identifikasi pasien *p-value* 0,003. Variabel tingkat pendidikan, lama kerja, waktu jaga, dan tingkat pengetahuan tidak terdapat hubungan dengan ketepatan identifikasi pasien, dengan *p-value* masing-masingnya 0,068; 0,733; 0,987; dan 0,191. Hasil penelitian kualitatif menunjukkan perawat belum optimal menerapkan ketepatan identifikasi pasien, sosialisasi kebijakan dan SOP belum berkelanjutan, pelatihan *patient safety* belum ke semua perawat, dan pengedukasian pasien belum optimal.

Kesimpulan

Pelaksanaan ketepatan identifikasi pasien sudah sesuai SOP, namun ada perawat pelaksana belum melaksanakan sesuai SOP karena sudah menjadi kebudayaan bagi perawat.

**ANALYSIS OF THE ACCURACY OF PATIENT IDENTIFICATION IN

ABSTRACT

Objective

Accuracy of patient identification is the goal of patient safety so it is necessary to identify the right patient to minimize errors. However, the implementation of patient identification is not optimal at the RSUD Lubuk Sikaping. This study aims to analyze the implementation of the accuracy of patient identification according to the SOP by nurses in the inpatient room RSUD Lubuk Sikaping.

Method

This study used mixed method with concurrent embedded models in June 2021 to April 2022. The number of samples in quantitative research is 40 respondents. This research was conducted to 22 informants using purposive sampling. Data was collected by in-depth interviews, observation, and document review.

Result

The results of quantitative on the implementation of patient identification accuracy according to the SOP (60%), the overall knowledge of the implementing nurses is in good category (90%). There is a relationship between the age of the nurse with the accuracy of patient identification with p-value 0.003. There's no relationship between the accuracy of patient identification with the variables of education level, length of work, watch time, and level of knowledge, with p-values of 0.068; 0.733; 0.987; and 0.191. the results of the qualitative research show that nurses have not applied the accuracy of patient identification optimally, socialization of policies and SOP have not been sustainable, patient safety training has not been given to all nurses, and patient education has not been optimal.

Conclusion

The implementation of patient identification has been appropriated by SOP, but there are some nurses still have not implemented it based on the SOP because it has been a culture for the nurses.
