CHAPTER V

CONCLUSION AND SUGGESTION

5.1 Conclusion

After analyzing the novel *Dear Justyce* by Nic Stone, the writer could understand that the author tried to bring up the racial discrimination issues in the United States reflected in the story. This novel reflected how black people should live with all the wrong stereotypes about them, even police officers and law that should have been fair turning back and attacking their freedom and rights. It seems like Stone, as a writer, takes this story from the actual event in the United States, where police officers and criminal justice inequalities do not work for minority races.

Firstly, the analysis shows the kind of racial discrimination that happened to black people. This can be concluded that after many incidents that happened to black people due to racial discrimination, racial discrimination still occurs in the United States. The incident of police brutality that caused a lot of black people to die and be injured keeps happening again and again. Some cases even have to be dismissed, and the police do not get any charge because they said they defended themselves from black people, who do not have a gun like them.

In other cases, black people get a high charge for stealing a deck of cards or being a suspect thief and accused of dangered other people. Even if they did not do anything and did not injure others people, black people were already aware of this case themselves. They tried to explain the actual incident to the police. Still, the lousy stereotype about their behavior in society did not give them a chance to present their position to the police and their environment.

Secondly, is the impact of racial discrimination that happened to black people, build them different from the other races. They were often violent when police officers wanted to arrest them because sometimes they were being arrested for something they did not do. As an impact of this, black people felt alone and weak because they did not have people on their side and stand with them to listen to the real story about their case or incident.

Overall, police brutality and criminal justice inequalities had a massive relation to racial discrimination since they significantly impacted black people in the United States. The impacts of that racial discrimination are they are being violent to protect themselves and feel powerless in society and front of criminal justice.
