**ANALISIS IMPLEMENTASI TUGAS KOMISI PENANGGULANGAN AIDS
KOTA PADANG DALAM MENANGGULANGI HIV/ AIDS TAHUN 2016**

ABSTRAK

Tujuan

Angka kasus HIV/ AIDS di Kota Padang masih tinggi. Data kasus HIV tahun 2014 adalah 225 kasus, AIDS 95 kasus dan meninggal 11 kasus dan tahun 2015 HIV adalah 227 kasus, AIDS 81 kasus dan meninggal 4 kasus. Upaya penanggulangan AIDS telah dilaksanakan oleh KPA Kota Padang, tetapi belum terkoordinir dengan baik. Tujuan penelitian adalah menganalisis implementasi tugas KPA Kota Padang dalam menanggulangi HIV/ AIDS.

Metode

Penelitian ini menggunakan metode kualitatif dengan pendekatan sistem, informan penelitian berjumlah 9 orang, penentuan informan dilakukan secara *purposive sampling*. Pengumpulan data dilakukan melalui wawancara mendalam, observasi, dan telaah dokumen. Analisis data dilakukan dengan cara triangulasi sumber dan triangulasi metode.

Hasil

Hasil penelitian dari segi input menunjukkan bahwa dari segi tenaga, dana, sarana dan prasarana masih terdapat kekurangan. Dari segi proses, belum ada rencana strategis dan pembagian tugas masing-masing instansi dalam penanggulangan HIV/ AIDS di Kota Padang, pada saat rapat koordinasi instansi tidak mengutus perwakilan yang tetap, serta belum dilibatkannya semua pihak dalam penanggulangan AIDS. Perwako, Perda Kota Padang serta Instruksi Walikota terkait Upaya Penanggulangan HIV/ AIDS masih belum ditetapkan. Dari segi output, implementasi tugas masih belum maksimal.

Kesimpulan

Implementasi tugas KPA Kota Padang masih belum maksimal. Diharapkan kepada KPA Kota Padang agar segera mencari solusi atas masalah kekurangan tenaga, dana, sarana dan prasarana dengan Walikota Padang selaku Ketua KPA Kota Padang, mengawal pembentukan Perwako, Perda, dan Instruksi Walikota terkait Upaya Penanggulangan HIV dan AIDS, memperbaiki koordinasi dengan instansi terkait, serta memperkuat dan memperluas kerjasama dengan Instansi, LSM, BUMN, maupun pihak swasta yang ada di Kota Padang.

**ANALYSIS OF TASK IMPLEMENTATION OF HIV/AIDS CONTROL BY
PADANG CITY AIDS COMMISSION IN 2016**

ABSTRACT

Objective

The number of HIV/ AIDS cases in Padang city is relatively high. In 2014, the data of HIV cases showed 225 cases, which were 95 cases of AIDS and 11 cases died. In 2015, the total case of HIV showed 227 cases, which were 81 cases of AIDS and 11 cases died. AIDS prevention efforts have been undertaken by AIDS Commission, but not well coordinated. The research objective is to analyze the task implementation of HIV/AIDS control by Padang AIDS Commission.

Method

This research is a qualitative method by an approach system, the total of research informant is 9 informants, the informant determined by purposive sampling. Data collected by indepth interviews, observation, and documents review. Data analysed by triangulation sources and triangulation methods.

Result

The research result of input terms showed that there are shortages in terms of human resources, funds, facilities and infrastructure. The research result of process terms showed there has been no strategic plan and division of tasks in each agency on HIV/AIDS control in Padang City. Beside that, each agency did not deliver the same representative person for the coordination meeting and also most all the parties have not been involved in AIDS control. District Regulation, Mayor Regulation, and Instructions of Mayor Efforts to Control HIV/AIDS are still not defined. The research result of output terms showed that Padang AIDS Commission was not optimally done their duties.

Conclusion

The task implementation of Padang AIDS Commission was not optimally. It is expected to Padang City AIDS Commission to solve the problem and seeking for a solution about the shortages of human resources, funds, facilities and infrastructure immediately and it is needed to discuss with the Mayor of Padang as the Chairman of Padang AIDS Commission regarding the initiation of District Regulation, Mayor Regulation, and Instructions of Mayor Efforts to Control HIV/AIDS, to improve the coordination with relevant agencies, and to strengthen and expand collaboration with agencies, NGOs, enterprises, and private parties in Padang City.
