EVALUASI PELAKSANAAN MANAJEMEN LOGISTIK ALAT KESEHATAN DI PUSKESMAS TALAWI KOTA SAWAHLUNTO TAHUN 2016

ABSTRAK

Tujuan

Pelaksanaan manajemen logistik alat kesehatan di Puskesmas Talawi yang juga puskesmas rawatan belum berjalan dengan baik, 233 unit dari 486 alat kesehatan dalam keadaan kurang baik. Selain itu alat kesehatan belum dikalibrasi. Tujuan penelitian untuk mengevaluasi pelaksanaan manajemen logistik alat kesehatan di Puskesmas Talawi Kota Sawahlunto tahun 2016.

Metode

Jenis penelitian kualitatif, teknik penentuan informan *purposive sampling*. Informan penelitian 6 orang dengan pengumpulan data melalui wawancara mendalam, observasi, dan telaah dokumen. Data diolah melalui reduksi data, penyajian data, dan penarikan kesimpulan, setelah itu dilakukan triangulasi.

Hasil

Hasil penelitian *input*, tenaga pelaksana satu orang bendahara barang dan satu orang penanggungjawab di setiap ruangan, dana berasal dari APBD melalui Dinas Kesehatan, sarana dan prasarana sudah mulai lengkap, metode pelaksanaan sudah sesuai dengan Permendagri No. 17 tahun 2007 ditambah dengan keputusan kepala puskesmas mengenai penanggung jawab inventaris ruangan. Pada komponen proses, perencanaan sudah dilaksanakan, alat kesehatan langsung didistribusikan kepada masing-masing ruangan. Pemeliharaan alat sudah terlaksana, penghapusan sudah terlaksana, pengawasan dilakukan satu kali dalam enam bulan.

Kesimpulan

Pelaksanaan manajemen logistik alat kesehatan di Puskesmas Talawi sudah terlaksana, namun masih terdapat beberapa kendala, pada proses pemeliharaan belum adanya kalibrasi terhadap alat kesehatan dan petugas khusus dalam perbaikan alat kesehatan. Saran agar adanya teknisi khusus dan kalibrasi alat kesehatan untuk menjamin kondisi alat tetap terjaga sesuai spesifikasinya.

EVALUATION OF LOGISTICS MANAGEMENT OF HEALTH MEDICAL EQUIPMENT AT TALAWI HEALTH CENTER OF SAWAHLUNTO 2016

ABSTRACT

Objective

Implementation of management at Talawi health center not run well, be inferred from the discovery of 233 from 468 of medical equipment in unfavorable circumstances. In addition medical equipment at Talawi health center has not been calibrated. This may affect the services provided. This research aimed to evaluate the implementation of logistics management of medical equipment at Talawi health centers Sawahlunto 2016.

Method

Qualitative research method, informant determining technique was purposive sampling. The informants are 6 people, data collected through interviews, observation, and study documents. The data is processed through data reduction, data presentation, and conclusion, after that triangulation.

Result

The research result input, implementers one person, health center do not have separate funds for the procurement of medical equipment, facilities and infrastructure to support the logistics management of medical equipment has begun to complete, the method in the implementation of logistics management of medical equipment at Talawi health center based Permendagri No.17 tahun 2007. In the process components, planning for medical equipment is done by the bottom-up method, the tool directly distributed to each unit. Maintenance tools do only light treatment by officers in the room, removal is done once a year, the supervision is done once in six months. On the output component, implementation logistics management of medical equipment at Talawi health center has been successful, but there are still some obstacles.

Conclusion

There are some obstacles in the implementation of logistics management of medical equipment such as lack of calibration on medical equipment, the lack of specialized personnel in the repair of medical equipment. It is therefore recommended that the specialized technicians and calibration of medical equipment to ensure the condition of the tool is maintained according to specifications.
