**ABSTRAK**

**Tujuan Penelitian**

Universitas Andalas menjadi *pilot project* dalam program kampus sehat di Indonesia. Salah satu indikator kampus sehat adalah pencegahan dan pengendalian penyakit tidak menular yaitu dalam bentuk Posbindu PTM. Penelitian ini bertujuan untuk mengetahui implementasi Posbindu PTM dalam program kampus sehat di Universitas Andalas Tahun 2022.

**Metode**

Jenis penelitian kualitatif dengan pendekatan fenomenologi. Data dikumpulkan melalui wawancara mendalam, observasi, dan telaah dokumen. Dipilih 19 informan di Universitas Andalas berdasarkan *purposive sampling*. Indikator yang diteliti merupakan faktor implementasi kebijakan Edward III, yaitu komunikasi, disposisi, sumber daya dan struktur birokrasi.

**Hasil**

Posbindu PTM belum dikomunikasikan secara jelas kepada implementor dan sasaran. Disposisi berupa komitmen telah dimiliki implementor. Sumber daya implementasi belum memadai terutama sarana prasarana dan dana. Struktur birokrasi pada fragmentasi telah disesuaikan dengan fungsinya, namun SOP belum ada. Terdapat pelaksanaan posbindu PTM yang belum terlaksana dengan baik karena belum dilakukan secara menyeluruh di setiap fakultas.

**Kesimpulan**

Universitas Andalas diharapkan menyampaikan kebijakan mengenai Posbindu PTM ini kepada seluruh civitas akademika di Universitas Andalas. Tim Kampus Sehat dilakukan pelatihan khusus kembali, SOP pelaksanaan Posbindu PTM Kampus Sehat harus segera dibuat, bertanggung jawab secara maksimal terhadap tugas dan tanggung jawabnya masing-masing, dan Pembentukan Posbindu PTM diharapkan dapat dilaksanakan secara menyeluruh di setiap fakultas.

**ABSTRACT**

**Objective**

Andalas University is a pilot project in a healthy campus program in Indonesia. One of the indicators of a healthy campus is the prevention and control of non-communicable diseases, namely in the form of PTM Posbindu. This study aims to determine the implementation of PTM Posbindu in the healthy campus program at Andalas University in 2022.

**Method**

Types of qualitative research with a phenomenological approach. Data was collected through in-depth interviews, observations, and document review. 19 informants at Andalas University were selected based on *purposive sampling*. The indicators studied are factors for the implementation of Edward III's policies, namely communication, disposition, resources and bureaucratic structure.

**Result**

Posbindu PTM has not been clearly communicated to implementors and targets. The disposition in the form of commitment has been owned by the implementor. Implementation resources are inadequate, especially infrastructure and funds. The bureaucratic structure of fragmentation has been adjusted to its function, but SOPs do not yet exist. There is a PTM post implementation that has not been carried out properly because it has not been carried out thoroughly in each faculty.

**Conclusion**

Andalas University is expected to convey the policy regarding this PTM Posbindu to the entire academic community at Andalas University. The Healthy Campus Team conducted special training again, the SOP for the implementation of the Healthy Campus PTM Posbindu must be made immediately, be fully responsible for their respective duties and responsibilities, and the establishment of the PTM Posbindu is expected to be carried out thoroughly in each faculty.
