ABSTRAK

Tujuan Penelitian

Peraturan Menteri Kesehatan RI No 24 Tahun 2022 tentang Rekam Medis Elektronik menyatakan bahwa seluruh fasilitas pelayanan kesehatan wajib menyelenggarakan rekam medis elektronik paling lambat 31 Desember 2023. Oleh sebab itu, RSUD dr. Rasidin Padang yang merupakan fasilitas pelayanan kesehatan wajib untuk melaksanakan rekam medis elektronik. Tujuan penelitian ini adalah menganalisis kesiapan pelaksanaan rekam medis elektronik di RSUD dr. Rasidin Padang.

Metode

Penelitian dilaksanakan pada November hingga Juni tahun 2023 menggunakan metode kualitatif. Informan berjumlah 6 orang dengan penentuan secara *purposive sampling*. Pengumpulan data melalui wawancara mendalam, observasi dan telaah dokumen. Analisis data dilakukan dengan triangulasi sumber dan triangulasi metode.

Hasil

Hasil penelitian menunjukkan dari segi kesiapan budaya organisasi belum ada timeline kegiatan perencanaan dan kebijakan untuk penerapan rekam medis elektronik. Dari segi kesiapan SDM belum ada dilakukan pelatihan terkait pelaksanaan RME. Dari segi kesiapan hardware komputer sudah dicukupkan dan software masih di tahap penyempurnaan aplikasi RME.

Kesimpulan

Kesiapan pelaksanaan RME masih perlu ditingkatkan, seperti kesiapan budaya organisasi, SDM, hardware dan software. Diharapkan rumah sakit mendorong kesiapan dalam peralihan rekam medis manual ke elektronik dengan sosialisasi dan pelatihan yang perlu segera di adakan mengingat RME harus terlaksana paling lambat 31 Desember 2023.

**ANALYSIS OF THE READINESS TO IMPLEMENTATION ELECTRONIC MEDICAL
RECORDS AT RSUD dr. RASIDIN PADANG**

ABSTRACT

Objective

Regulation of the Minister Health of the Republic Indonesia No. 24, 2022 concerning Electronic Medical Records states that all health service facilities are required to maintain electronic medical records no later than December 31, 2023. Therefore, RSUD dr. Rasidin Padang which is a health service facility is also required to carry out electronic medical records. The purpose of this study was to analyze the readiness of implementing electronic medical records at dr. Rasidin Padang.

Method

The research was conducted from November to June 2023 using qualitative methods. Informants amounted to 6 people by purposive sampling. Data collection through in-depth interviews, observation and document review. Data analysis was performed by source and method triangulation.

Result

The results of the study show that in terms of organizational culture readiness there is no timeline for planning activities and policies for the implementation of EMR. In terms of the readiness of human resources, there has been no training or outreach related to the implementation of EMR. In terms of computer hardware readiness, it has been sufficient and the software is still in the stage of perfecting the EMR application.

Conclusion

EMR implementation readiness still needs to be improved, such as organizational culture readiness, Human Resources (HR), hardware and software readiness. Hoped that the hospital will encourage readiness to transition from manual to electronic medical records with socialization and training that needs to be held immediately considering that EMR must be carried out no later than December 31, 2023.
