ABSTRAK

Tujuan Penelitian

Kelengkapan pengisian rekam medis di Rumah Sakit Universitas Andalas belum memenuhi SPM. Tujuan penelitian ini untuk mengetahui gambaran terkait kelengkapan pengisian rekam medis rawat inap pada pasien JKN di Rumah Sakit Universitas Andalas Padang tahun 2022.

Metode

Penelitian ini adalah *mix-method* secara *Sequential Explanatory Design*. Sampel penelitian terdiri dari 95 status rekam medis rawat inap Eboli yang dipilih menggunakan sistem *Random Sampling* dan dianalisis dengan metode analisis univariat. Sedangkan informan dipilih secara *purposive sampling*, dan dianalisis dengan metode analisis isi.

Hasil

Kelengkapan rekam medis rawat inap pada pasien JKN sebesar 94,6% dengan persentase kelengkapan terendah pada komponen laporan penting yaitu sebesar 88,3%. Hasil wawancara mendalam pada komponen *input*: tenaga kerja belum cukup, dana sudah disediakan, metode sudah sesuai alur yang ditetapkan, material sudah cukup, namun sarana dan prasana masih kurang. Komponen *process*: pendaftaran pasien sudah berjalan sesuai alur, pengisian rekam medis masih belum lengkap, analisis rekam medis belum berjalan rutin sehingga pelaporan juga belum rutin. Komponen *output*: kelengkapan pengisian rekam medis rawat inap pasien JKN masih tidak lengkap.

Kesimpulan

Pengisian rekam medis rawat inap pada pasien JKN belum mencapai SPM baik dari rumah sakit Universitas Andalas maupun Nasional yaitu 100%. Diharapkan tenaga profesional patuh dalam pengisian rekam medis berdasarkan aturan yang telah ditetapkan.

ANALYSIS OF THE COMPLETENESS OF INPATIENT MEDICAL RECORD FILLING IN NHI PATIENTS AT ANDALAS UNIVERSITY HOSPITAL IN 2022

ABSTRACT

Objective

Completeness of filling out medical records at Andalas University Hospital has not met MSS. The purpose of this study was to determine the description related to the completeness of filling out inpatient medical records in NHI patients at Andalas University Hospital Padang in 2022.

Methods

This research is a mix-method Sequential Explanatory Design. The research sample consisted of 95 Eboni inpatient medical record statuses selected using the Random Sampling system and analyzed by the univariate analysis method. While informants were selected by purposive sampling, and analyzed by content analysis method.

Results

The completeness of inpatient medical records for NHI patients was 94.6% with the lowest percentage of completeness in the important report component, which was 88.3%. The results of in-depth interviews on the input component: labor is not enough, funds have been provided, methods are in accordance with the established flow, material availability is sufficient, but facilities and infrastructure are still lacking. Process component: patient registration has been running according to the flow, filling in medical records is still incomplete, medical record analysis has not been running routinely so that reporting is also not routine. Output component: the completeness of filling in the medical records of NHI inpatients is still incomplete.

Conclusion

The filling of inpatient medical records in NHI patients has not yet reached MSS from both Andalas University and National hospitals, namely 100%. It is expected that professionals comply in filling medical records based on established rules.
