**ABSTRAK**

**Tujuan Penelitian**

Cakupan K1 dan K4 di Puskesmas Magek Kabupaten Agam tahun 2016 masih rendah, rendahnya cakupan K1 dan K4 dapat mempengaruhi kehamilan resiko tinggi pada ibu hamil. penelitian ini bertujuan menganalisis pelaksanaan program pelayanan kesehatan ibu hamil di Wilayah Kerja Puskesmas Magek Kabupaten Agam tahun 2017

**Metode**

Penelitian ini menggunakan metode penelitian kualitatif dengan pendekatan sistem. Informan penelitian berjumlah 9 orang (1 Kabid Kesmas, 1 Kasie Kesga-gizi Dinkes Agam, 1 Kepala Puskesmas, 1 Bidan Koordinator/ pengelola KIA, 2 Bidan Pustu, 3 Ibu hamil yang telah K1 dan K4 dengan teknik wawancara mendalam, observasi dan telaah dokumen.

**Hasil**

Hasil penelitian terkait ketersediaan tenaga bidan belum sesuai standar, latar belakang pendidikan sudah sesuai standar DIII kebidanan. Dana mencukupi, sarana dan prasarana perlu perbaikan. SOP belum ada, Perencanaan terdiri dari Renja mingguan, bulanan dan tahunan. Pengorganisasian sudah berjalan dengan baik, Pelaksanaan masih belum optimal, perlu adanya peningkatan pelayanan yang diberikan oleh bidan. Pengawasan yang dilakukan Dinas Kesehatan belum *continue*. Cakupan K1 dan K4 belum mencapai target yang ditetapkan.

**Kesimpulan**

Rendahnya cakupan K1 dan K4 di wilayah kerja Puskesmas Magek dipengaruhi oleh tenaga, sarana, prasarana, SOP, pelaksanaan (pelayanan) dan pengawasan. Dinas Kesehatan Kabupaten Agam diharapkan melakukan pemenuhan kebutuhan tenaga bidan serta melakukan pengawasan secara *continue*, Kepala Puskesmas dapat melakukan perbaikan sarana dan prasarana serta meningkatkan kerja sama lintas sektor seperti KUA (Kantor Urusan Agama), kecamatan, serta tokoh masyarakat, bidan desa dapat lebih aktif menjangkau ibu hamil dan meningkatkan pelayanan yang diberikan.

**ABSTRACT**

**Research purposes**

K1 and K4 coverage at Magek Health Center of Agam District in 2016 has low, low coverage of K1 and K4 can affect pregnancy in pregnant women. The research purpose to analyze the implementation of pregnant women's health service program at Magek Health Center of Agam Regency in 2017.

**Method**

This research uses Qualitative method with System Approach. The research informants consisted of 9 people (Head Kesmas, Head Kesga-Gizi of Agam District Health Office, Head of Magek Health Center, Midwife Coordinator / KIA Manager, Midwives, K1 and K4 Mom) with in-depth interview, observation and document review.

**Results**

The result of the research related to the availability of midwife was not in accordance with standard, the midwife's education background is in accordance with D III standard of obstetrics, the fund is funded by BOK, DAU and JKN. Facilities not yet up to standard, still need improvement. SOP of pregnant women's health services is not yet available. Planning consists of Renja weekly, monthly and yearly. Organizing is going well, but there is no special structure. Implementation is still not optimal, it is necessary to improve the services provided by the midwife. Supervision made by Agam District Health Office has not continued. The coverage of K1 and K4 in the work area of Magek Public Health Center has not reached the set target.

**Conclusion**

The low coverage of K1 and K4 in the work area Magek Public Health center is influenced by personnel, facilities, basic facilities, SOP, implementation (service) and supervision. Agam District Health Office is expected to conduct continuous monitoring, Head of Puskesmas can increase cross-sectoral cooperation such as KUA (Office of Religious Affairs), districts, public figure in getting pregnant mother, Village midwife and cadre area can be more active to find pregnant women and improve services.
