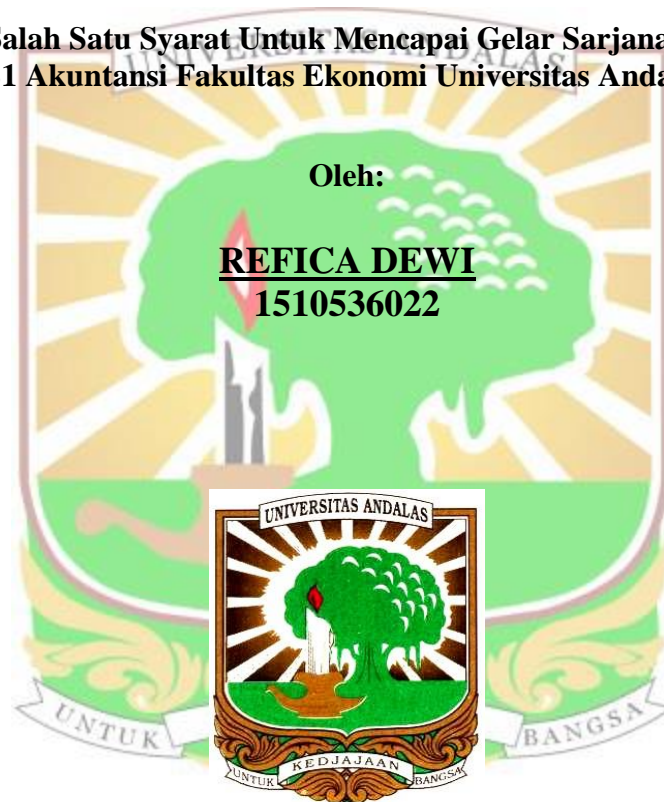

ABSTRACT

The purpose of this research is to know the application of state own property administration managed by Andalas University in accordance with Decree of the Minister of Finance Number 181 Year 2016 on State Own Property Administration and the implementation of state assets recording using the application of The State Property's Accounting and Management Information System (known as SIMAK BMN) in accordance with Decree of the Minister of Finance Number 213 Year 2013 on Central Government Accounting and Financial Reporting System (known as SAPP) as amended by the Decree of the Minister of Finance Number 215 Year 2016. The research is in form of qualitative research by descriptive design.

The results of this research shows that the administration of state own property in Andalas University produced the degree of conformity about 88% or categorized as suitable categorized of Decree of the Minister of Finance Number 181 Year 2016. The application of state assets recording using SIMAK BMN produced the degree of conformity about 93% or categorized as suitable categorized of Decree of the Minister of Finance Number 213 Year 2013 as amended by the Decree of the Minister of Finance Number 215 Year 2016
