BAB VI

CONCLUSION

6.1 Conclusion

Conclusions that can be taken from the study "Contributions of Productive Zakat on Mustahik HDI in Padang city" are as follows:

- 1. The number of poor people in West Sumatra has experienced a decline, especially in Padang city, from 404,736 people to 397,885 from the 2015-2017 period.
- 2. The development of independent variables (Productive Zakat Distribution) on increasing HDI in the city of Padang in 2018
- 3. Based on the regression results Productive Zakat variable that has a positive effect on the improvement of Mustahik HDI in Padang city
- 4. The determinant coefficient (R^2) is 0.79. This means that 79% of the independent variables namely productive DBU Finance affect the Mustahik HDI increase while the remaining 21% is influenced by other variables
- 5. Based on the results of the research, the productive DBU Finance variable has a positive effect on Mustahik HDI
- 6. Based on the result of the research, the number of Family Size has negative relationship on Mustahik HDI

1.2 Advice

Based on the conclusions of the research results, several efforts that need to be made to improve Mustahik's HDI in Padang City include:

- In increasing HDI in the city of Padang, the regional government and BAZNAS must work together in improving Mustahik's HDI by making useful programs not only for consume but for productive sector in terms of economy
- 2. In carrying out its BAZNAS program, especially BAZNAS, Padang city must increase its distribution range so that the distribution can reach places that have not been touched by assistance from BAZNAS, so the influence can be greater in increasing HDI Mustahik
- 3. KB Programs or should shoul be integrated with BAZNAS Padang in order to give information to Mustahik that already receive the DBU should control their number of children to anticipate of HDI decreasing
