**ABSTRACT**

Governance Hospital (GH) is a working group that is in the National Standards Accreditation of Hospitals (SNARS Issue 1 2018). This standard is assessed in its application in the hospital. Descriptive qualitative study conducted using the method of observation and interviews as well as using software ATLAS.ti 8 read the transcript of in an interview with the Commissioner, the Director and the Internal Audit Unit (IAU). Governance Hospital (HG) were also assessed from the application of the standards that have been done in the hospital, to assess Good Corporate Governance be based on the principle of Fairness, Transparency, Accountability, responsibility and Indenpendency arranged and adapted to the instrument Governance Hospital (HG).

The results showed that the application of the Governance Hospital (HG) based on National Instruments Hospital Accreditation Standards (SNARS) and the principles of Good Corporate Governance Tamar's Hospital Medical Center (RS.TMC) has not been implemented optimally resulting limitations of staff or human resources are willing to do.

## ABSTRAK

Tata Kelola Rumah Sakit (TKRS) merupakan salah satu kelompok kerja yang ada di dalam Standar Nasional Akreditasi Rumah Sakit (SNARS Edisi 1 2018). Standar ini dinilai didalam penerapannya di Rumah Sakit. Penelitian kualitatif deskriptif dilakukan dengan menggunakan metode observasi dan wawancara serta menggunakan *software* Atlas.ti 8 di dalam membaca transkrip wawancara dengan Komisaris, Direktur dan Satuan Pengawasan Internal (SPI). Tata Kelola Rumah Sakit (TKRS) juga dinilai dari penerapan standar-standar yang sudah dilakukan di Rumah Sakit, untuk menilai *Good Corporate Governance* dilihat berdasarkan prinsip – prinsip *Fairness, Transparency, Accountability, Responsibility* dan *Indenpendency* yang disusun dan disesuaikan dengan Instrumen Tata Kelola Rumah Sakit (TKRS).

Hasil penelitian menunjukan bahwa penerapan Tata Kelola Rumah Sakit (TKRS) berdasarkan Instrumen Standar Nasional Akreditasi Rumah Sakit (SNARS) dan prinsip-prinsip *Good Corporate Governace* di Rumah Sakit Tamar Medical Centre (RS.TMC) belum dilaksanakan secara maksimal yang disebabkan keterbatasan dari staf atau sumber daya manusia yang mau mengerjakan.
