

ABSTRAK

Tujuan Penelitian

Kelengkapan pengisian rekam medis dirumah sakit Tentara Bukittinggi belum memenuhi SPM Rekam Medis. Tujuan penelitian ini adalah untuk mengetahui informasi mengenai kelengkapan pengisian rekam medis dirumah sakit Tentara Bukittinggi tahun 2018.

Metode

Desain penelitian ini adalah kualitatif-kuantitatif (*Mix-Methode*) dengan pendekatan sistem dari *input, proses* dan *output*. Sampel dalam penelitian ini terdiri dari 92 status rekam medis rawat inap dan 95 status rekam medis rawat jalan yang dipilih menggunakan sistem *Random Sampling*. Sedangkan untuk informan penelitian ditentukan berdasarkan *purposive sampling*.

Hasil

Hasil penelitian Kelengkapan pengisian rekam medis masih kurang. Ketidaklengkapan pengisian rekam medis rawat inap dari segi identifikasi pasien (2,4%), laporan penting (34,76%), authentifikasi (50,19%) dan pencatatan yang benar (50,01%). Sedangkan untuk ketidaklengkapan pengisian rekam medis pasien rawat jalan dari segi identifikasi pasien (21,4%), laporan penting (57,2%), authentifikasi (82,14%) dan pencatatan yang benar (54,65%). Hasil penelitian dari aspek *input* tenaga rekam medis masih kurang, dana untuk penunjang pelaksanaan rekam medis sudah memadai, metode tentang alur dan SOP sudah ada, alat dan bahan sudah cukup memadai, sarana dan prasarana untuk penunjang pelaksanaan rekam medis masih belum mencukupi. Aspek *proses* pada pendaftaran pasien khususnya untuk pencatatan identitas pasien sudah dicatat selengkap mungkin oleh petugas *admission*, pada pengisian rekam medis masih ada lembaran rekam medis yang tidak diisi oleh perawat dan dokter, untuk analisis isi rekam medis belum ada dilaksanakan di ruangan rekam medis, untuk pelaporan sudah ada namun petugas RM belum diikutsertakan.

Kesimpulan

Kelengkapan pengisian rekam medis belum berjalan sesuai dengan SPM. Diharapkan rumah sakit dapat melaksanakan rekam medis pasien sesuai dengan SOP. Untuk tenaga rekam medis perlu di optimalkan.

ABSTRACT

Research purposes

Completion of filling in the medical record at the Bukittinggi Tentara hospital had not met the Medical Record SPM. The purpose of this study was to find out information about the completeness of filling out the medical record at the Bukittinggi Tentara hospital, 2018.

Method

The design of this study was qualitative-quantitative (Mix-Method) with a system approach from input, process and output. The sample in this study consisted of 94 inpatient medical record statuses and 97 outpatient medical record status selected using the Random Sampling system. While for research informants determined based on purposive sampling.

Results

Research results Completeness of filling in medical records was still lacking.. Incomplete filling of inpatient medical records in terms of patient identification (2.4%), important reports (34.76%), authentication (50.19%) and correct recording (50.01%). As for the incompleteness of filling out outpatient medical records in terms of identification of patients (21.4%), important reports (57.2%), authentication (82.14%) and correct recording (54.65%). The research results from the input aspects of the medical record staff were still lacking, the funds to support the implementation of the medical record were adequate, methods for flow and SOPs were available, the tools and materials were sufficient, facilities and infrastructure to support the implementation of medical records were insufficient. The process aspect of patient registration especially for patient identity recording had been recorded as completely as possible by the admission officer, in filling out the medical record there was still a medical record sheet that was not filled by nurses and doctors, for the analysis of medical records content had not been conducted in the medical record room, for reporting already exists but the RM officer had not been included.

Conclusion

The completeness of filling in the medical record had not yet proceeded in accordance with the SPM. It is expected that the hospital can carry out the patient's medical record in accordance with the SOP. The medical record staff need to be optimized.
