

The sample consists of 8 manufacturing companies and 4 mining companies listed in IDX. This research analysis was carried out using paired sample t-test to examine the impact before adoption and after adoption of IT Governance. The result shows that there is no significance different in company performance between pre adoption and post adoption of IT Governance in manufacture and mining companies.
