

Pelaksanaan peningkatan mutu berkelanjutan di rumah sakit masih kurang memuaskan. Masalah ini disebabkan karena berbagai faktor diantaranya upaya peningkatan berkelanjutan melalui pelaksanaan audit keperawatan juga belum terlaksana dengan baik. Tujuan penelitian ini adalah untuk mengetahui hubungan pelaksanaan audit keperawatan dengan Pencapaian *continous quality improvement (CQI)*. Desain penelitian ini adalah observasional analitik dengan pendekatan *cross sectional*. Sampel dalam penelitian ini adalah perawat di RSJ. Tampan Provinsi Riau sebanyak 123 orang dengan teknik pengambilan sampel yaitu *proportional random sampling*. Hasil penelitian menunjukkan ada hubungan yang signifikan antara pelaksanaan audit sistem dengan Pencapaian *CQI* ($p\ value = 0,000 < \alpha = 0,05$), ada hubungan yang signifikan antara pelaksanaan audit kesesuaian dengan pencapaian *CQI* ($p\ value = 0,000 < \alpha = 0,05$) dan ada hubungan yang signifikan antara pelaksanaan audit produk dengan pencapaian *CQI* ($p\ value = 0,000 < \alpha = 0,05$). Hasil uji statistik *Binary Logistic* menunjukkan variabel audit produk merupakan menjadi variabel yang paling dominan berhubungan dengan pencapaian *CQI* (*odd ratio* = 79,9). Diharapkan kepada rumah sakit agar dapat menyusun kebijakan terhadap pelaksanaan audit pelayanan asuhan keperawatan di rumah sakit dengan cara pelatihan audit, workshop dan sosialisasi *CQI*, penyusunan SOP audit serta melakukan proses audit secara berkala oleh komite keperawatan di rumah sakit.



Analysis Nursing Audit Implementation with the Continous Quality Improvement (CQI) in Tampan Mental Hospital, Riau

The implementation of continuous quality improvement (CQI) in hospitals is still unsatisfactory. This problem is caused by various factors including the continuous improvement efforts through the implementation of the nursing audit that has not been implemented properly. The purpose of this study was to determine the relationship between continuous quality improvement (CQI) nursing audit. The design of this research is observational analytic with cross sectional approach. The sample in this study was nurses at the Tampan Mental Hospital, Riau as many as 123 people with a sampling technique that is proportional random sampling. The results showed that there was a significant relationship between the implementation of a system audit and CQI (p value = 0,000 $<\alpha = 0.05$), there was a significant relationship between the implementation of audits and CQI (p value = 0,000 $<\alpha = 0.05$) and there was a significant relationship between the implementation of product audits and CQI (p value = 0,000 $<\alpha = 0.05$). The results of the Binary Logistic statistical test show that the product audit variable is the most dominant variable associated with the implementation of CQI (odd ratio = 79.9). Recomendation of the research is expected that hospitals can formulate policies on the implementation of hospital nursing care services audits by training audits, workshops and CQI socialization, compiling audit SOP and conducting regular audits by the hospital nursing committee.
