

ABSTRAK

Tujuan Penelitian

Kebakaran di Batamindo Industrial Park terjadi 49 kali dalam rentang tahun 2016-2023. Risiko kebakaran dapat terjadi karena ketidaksesuaian pelaksanaan sistem tanggap darurat dengan standar. Tujuan penelitian ini untuk menganalisis pelaksanaan prosedur tanggap darurat, organisasi tanggap darurat, sumber daya manusia, pelatihan tanggap darurat, serta prasarana dan sarana tanggap darurat yang ada di PT. Batamindo Investment Cakrawala.



Metode

Penelitian ini merupakan penelitian kualitatif dengan 10 informan yang dipilih secara *purposive sampling*. Penelitian ini di Kota Batam pada PT. Batamindo Investment Cakrawala dari bulan November 2023 hingga Juli 2024. Pengumpulan data dilakukan melalui wawancara, observasi, dan telaah dokumen.

Hasil

Berdasarkan hasil dari analisis data penelitian didapatkan bahwa prosedur tanggap darurat, sumber daya manusia, pelatihan tanggap darurat, serta prasarana dan sarana tanggap darurat belum sesuai dengan Permen PU No. 20/PRT/M/2009 dan Permen PU No. 26/PRT/M/2008, namun organisasi tanggap darurat telah sesuai.

Kesimpulan

Pelaksanaan sistem tanggap darurat di PT. Batamindo Investment Cakrawala belum optimal karena masih ditemukan ketidaksesuaian berdasarkan Permen PU No. 20/PRT/M/2009 dan Permen PU No. 26/PRT/M/2008. Disarankan kepada PT. Batamindo Investment Cakrawala untuk melakukan audit sistem proteksi kebakaran, menambah jumlah serta memfasilitasi *training* kelas A dan kelas B kepada personel tanggap darurat.

ABSTRACT

Objective

Fires in Batamindo Industrial Park have occurred 49 times in the period 2016 and 2023. Fire risk can occur due to the non-conformity of the implementation of the emergency response system with the standard. The purpose of this study is to analyse the implementation of emergency response procedures, emergency response organisation, human resources, emergency response training, and emergency response facilities and infrastructure at PT Batamindo Investment Cakrawala.

Method

This research is a qualitative research with 10 informants selected by purposive sampling. The research was conducted in Batam City at PT Batamindo Investment Cakrawala from November 2023 to July 2024. Data were collected through interviews, observations, and document review.

Result

Based on the results of data analysis, it is concluded that emergency response procedures, personnel, emergency response training, and emergency response infrastructure and facilities are not in accordance with Permen PU No. 20/PRT/M/2009 and Permen PU No. 26/PRT/M/2008, but the organisation of emergency response is appropriate.

Conclusion

The implementation of emergency response system at PT Batamindo Investment Cakrawala was not optimal because there were still nonconformities based on Permen PU No. 20/PRT/M/2009 and Permen PU No. 26/PRT/M/2008. It is recommended to PT Batamindo Investment Cakrawala to audit the fire protection system, increase the number and facilitate class A and class B training for emergency response personnel.
