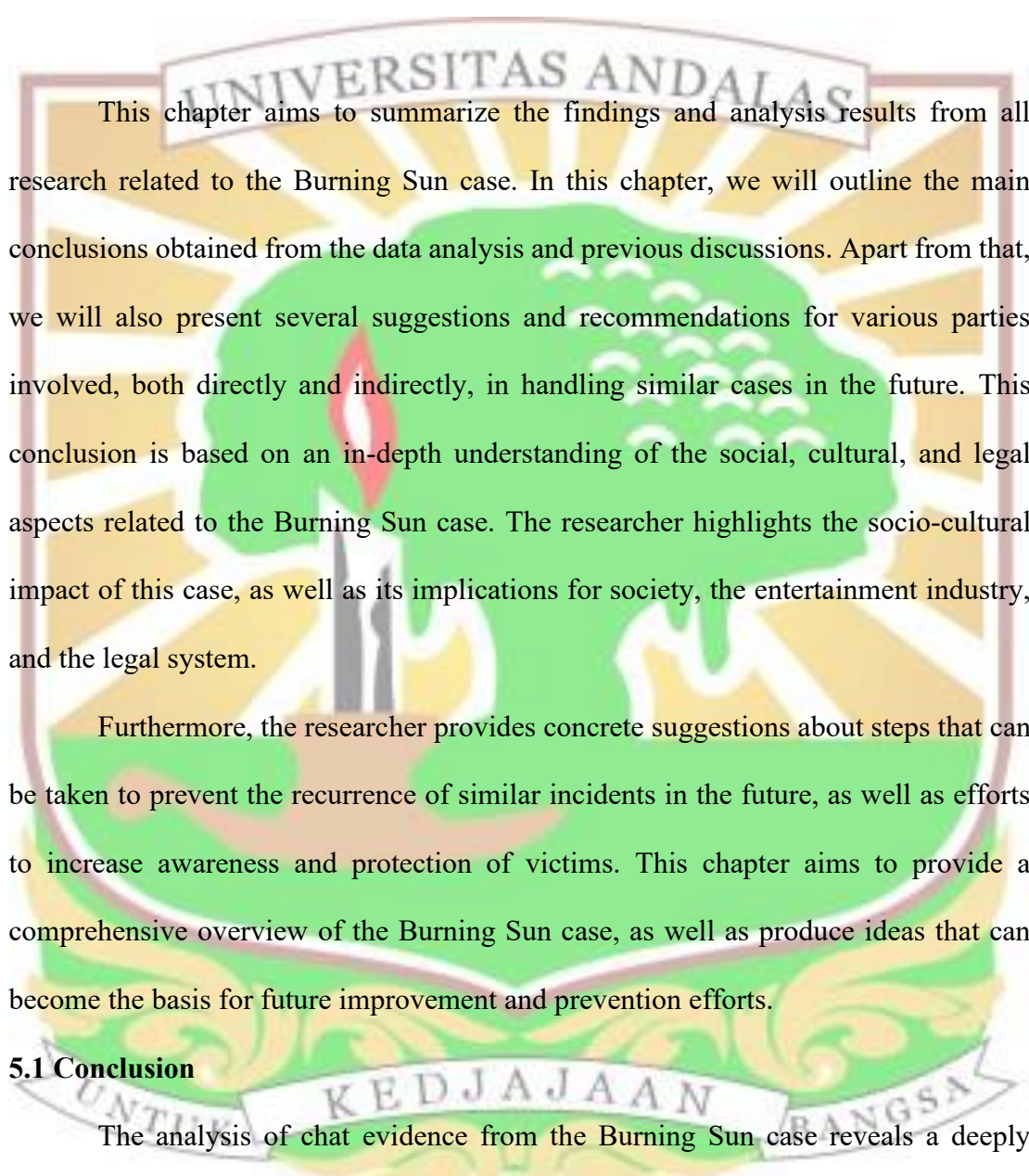


CHAPTER V

Seungri's commanding role and the compliance of other group members indicate a well-established hierarchy. His directives are followed without question, reflecting the power dynamics and respect for his authority within the group. This hierarchical structure is further emphasized by the use of honorifics and respectful language, showcasing the influence and control he holds over the others. The conversations reveal an environment where questioning authority is discouraged, thereby perpetuating a culture of impunity and reinforcing the status quo.

c. Syntactic Features Reflecting Dynamics

The syntactic analysis of the conversations reveals the dynamics, planning, and execution of actions. Imperative sentences indicate commands and directives, while interrogative sentences reflect logistical planning and the gathering of necessary information. The mix of simple and complex sentences provides a balance between

clear, concise instructions and detailed, comprehensive plans. This linguistic pattern underscores the calculated nature of their operations, where clarity and precision are paramount to avoid detection and ensure successful outcomes.

d. Cultural and Social Norms

The chats reveal the internalization of social norms and cultural preferences, such as the emphasis on fair-skinned women being preferred by Southeast Asian men. These preferences shape the decision-making process and the selection of women, reflecting a commercial and strategic approach to their illegal activities. This aspect highlights how deeply ingrained cultural biases and stereotypes are exploited for personal gain, perpetuating harmful social norms and contributing to the objectification and commodification of women.

e. Impact on Victims and Society

The illegal activities discussed in the chats, such as violence, sexual harassment, and the distribution of illegal videos, have significant negative impacts on victims and society. The hierarchical and organized nature of these activities highlights the systemic issues within the nightclub environment and the broader entertainment industry. Victims are often left with little recourse for justice, exacerbating their trauma and perpetuating a cycle of exploitation and abuse.

The normalization of these activities within the Burning Sun chats contributes to a culture where criminal behavior is trivialized and ethical standards are eroded. This normalization extends beyond the immediate group, influencing public perception and

potentially encouraging similar behavior in other sectors of society. The repeated references to illegal activities without any apparent fear of legal repercussions suggest a deeply rooted belief in their impunity, further undermining trust in the legal system and societal norms.

f. Suggestion

Based on the findings of this research, several suggestions can be put forward:

a. Expand the Scope of Data Collection

Future researchers should consider expanding the scope of their data collection to include a broader range of digital communication platforms. While this study focused primarily on chat evidence from KakaoTalk, incorporating data from other social media and messaging platforms such as Twitter, Instagram, and WhatsApp could provide a more comprehensive understanding of the extent and nature of criminal activities. Additionally, interviews with key informants and stakeholders could offer valuable insights that are not captured through chat evidence alone.

b. Utilize Mixed Methods Approaches

Combining quantitative and qualitative research methods can enhance the depth and breadth of the analysis. For example, quantitative content analysis could be used to identify patterns and frequencies of specific linguistic features or themes in the chat evidence, while qualitative approaches such as thematic analysis or narrative analysis could provide a deeper understanding of the context and implications of these patterns. Mixed methods approaches can also help triangulate findings and strengthen the validity of the conclusions drawn.
