Gambaran Pelaksanaan Timbang Terima (*Hand Over*) Di Ruang Rawat Inap  
Bedah Pria RSUP Dr. M. Djamil Padang

## ABSTRAK

Mutu pelayanan keperawatan merupakan indikator utama bagi suatu kualitas pelayanan kesehatan masyarakat. Salah satu mutu pelayanan yang harus ditingkatkan adalah timbang terima. Timbang terima yang tidak efektif dapat berdampak buruk terhadap pelaksanaan keselamatan pasien (*patient safety*). Timbang terima dalam pelaksanaannya masih belum sesuai dengan Standar Prosedur Operasional (SPO) dan tidak optimal. Pelaksanaan timbang terima di RSUP Dr. M. Djamil Padang khususnya ruang rawat inap bedah pria menerapkan timbang terima berdasarkan Standar Prosedur Operasional (SPO) berbasis SBAR. Tujuan studi kasus ini adalah untuk mengetahui gambaran pelaksanaan timbang terima di ruang rawat inap bedah pria RSUP Dr. M. Djamil Padang dengan menggunakan metode observasi selama enam hari. Hasil studi kasus didapatkan bahwa pelaksanaan timbang terima di ruang rawat inap bedah pria dilakukan setiap pergantian shift. Mekanisme timbang terima masih belum optimal dilakukan sesuai dengan SPO yang ada seperti perawat sering terlambat datang, tidak ada timbang terima obat dan alat. Metode timbang terima yang dilakukan secara lisan dan tulisan tangan melalui buku laporan timbang terima. Isi timbang terima masih belum optimal mengikuti komunikasi SBAR. Perawat tidak menyampaikan aspek *situation* seperti lama hari rawatan, nomor rekam medis, dan tanggal lahir pasien. Perawat juga tidak menyampaikan aspek *assessment* seperti tanda-tanda vital. Disarankan kepada pihak manajemen RSUP Dr. M. Djamil Padang untuk mengevaluasi kembali pelaksanaan timbang terima dan melakukan supervisi terhadap perawat yang melaksanakan timbang terima yang tidak sesuai dengan SPO yang ada.

*Study of Implementation Handover in the Men's Surgical Hospitalize Room at Dr. Hospital. M. Djamil Padang*

**ABSTRACT**

*The quality of nursing services is the main indicator for the quality of public health services. One of the quality of services that must be improved is consideration. Ineffective consideration can have a negative impact on the implementation of patient safety. The application of hand over have many problems and not match with SPO. Carrying out a weigh-in at RSUP Dr. M. Djamil Padang, especially the male surgical inpatient room, applies acceptance considerations based on SBAR-based Standard Operating Procedures (SPO). The aim of this study was to find out the description of the implementation of the weigh-in in the men's surgical inpatient room at RSUP Dr. M. Djamil Padang using the observation method for six days. The results of the research showed that acceptance weighing was carried out in the male surgical inpatient room at every shift change. The weigh-in mechanism is still not optimally carried out in accordance with existing SOPs, such as nurses often arriving late, there is no weigh-in for medicines and equipment. The weigh-in method is carried out verbally and handwritten through a weigh-in report book. The contents of the weigh-in are still not optimal following SBAR communication. Nurses do not convey situational aspects such as length of treatment days, medical record number, and patient's date of birth. Nurses also do not convey assessment aspects such as vital signs. It is recommended that Hospital of RSUP Dr. M. Djamil Padang Staff to re-evaluate the implementation of acceptance weigh-ins and supervise nurses who carry out acceptance weigh-ins that are not in accordance with existing SOPs.*
