ABSTRAK

Tujuan

Puskesmas Kurai Taji telah melaksanakan fungsi-fungsi manajemen logistik, namun masih terdapat beberapa masalah yaitu jumlah alat kesehatan yang masih kurang dan belum adanya gudang tempat penyimpanan alat kesehatan. Tujuan penelitian ini untuk mengevaluasi pelaksanaan manajemen logistik alat kesehatan di Puskesmas Kurai Taji Kota Pariaman tahun 2018.

Metode

penelitian ini menggunakan metode penelitian kualitatif dengan pendekatan sistem. Informan berjumlah 7 orang yang ditentukan melalui teknik *purposive sampling*. Pengumpulan data dilakukan dengan wawancara mendalam, observasi lapangan, dan telaah dokumen. Analisis data dengan cara triangulasi sumber dan triangulasi metode

Hasil

Hasil penelitian dari segi Input menunjukkan tenaga pengelola alat kesehatan yang masih kurang, dana bersumber dari APBD, APBN dan Kapitasi JKN, penyediaan sarana dan prasarana belum optimal, SOP (*standard operating Procedure*) yang belum ada. Pada komponen proses, perencanaan sudah berjalan dengan baik, puskesmas tidak mempunyai anggaran khusus, tidak adanya gudang tempat penyimpanan alat kesehatan di puskesmas, alat kesehatan langsung didistribusikan kepada masing-masing ruangan, pemeliharaan sudah terlaksana, penghapusan belum terealisasi, pengendalian dilakukan dengan membuat KIR, KIB dan aplikasi program ASPAK namun, kodifikasi barang belum terlaksana.

Kesimpulan

Pelaksanaan manajemen logistik alat kesehatan di Puskesmas Kurai Taji belum optimal. Masih terdapat beberapa kendala dari segi tenaga, penyimpanan, pemeliharaan, penganggaran, penghapusan dan pengendalian. Disarankan kepada Puskesmas Kurai Taji dapat mengacu pada Permenkes No. 75 Tahun 2014 tentang Puskesmas agar pengelolaan manajemen logistik alat kesehatan dapat berjalan secara maksimal dan terarah.

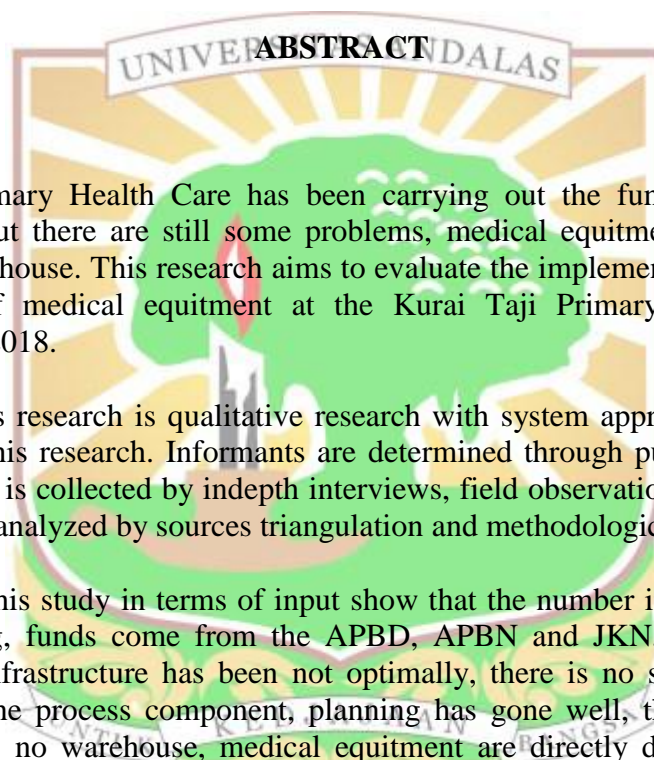

Objective

Kurai Taji Primary Health Care has been carrying out the function of logistics management, but there are still some problems, medical equipment still lacks and there is no warehouse. This research aims to evaluate the implementation of logistics management of medical equipment at the Kurai Taji Primary Health Care in Pariaman City 2018.

Method

The type of this research is qualitative research with system approach. There are 7 Informants in this research. Informants are determined through purposive sampling technique. Data is collected by indepth interviews, field observations, and document review. Data is analyzed by sources triangulation and methodological triangulation

Result

The results of this study in terms of input show that the number implementing staff are still lacking, funds come from the APBD, APBN and JKN, the provision of facilities and infrastructure has been not optimally, there is no standard operating procedure. In the process component, planning has gone well, there is no special budget, there is no warehouse, medical equipment are directly distributed to each room, maintenance has been carried out, deletion has not been implemented well, control has been done by making KIR, KIB and ASPAK program, however, the codification of the item has not been implemented.

Conclusion

The implementation of logistic management of medical equipment at the Kurai Taji Primary Health Care has not run optimally. There are several obstacles in terms of implementing staff, storage, maintenance, budgeting, detetion and controlling. It is recommended to Kurai Taji Primary Health Care refer to the Minister of Health Regulation No. 75 of 2014 so that the logistics management of medical equipment can run optimally and directed.
