ABSTRAK

Tujuan penelitian

Penelitian ini bertujuan untuk menganalisis tingkat kelengkapan pengisian rekam medis pasien rawat inap di Rumah Sakit Universitas Andalas Tahun 2025. Analisis difokuskan pada persentase kelengkapan berdasarkan empat aspek utama, yaitu identifikasi pasien, laporan penting, autentikasi, serta ketepatan pencatatan.

Metode

Penelitian ini menggunakan metode deskriptif kuantitatif. Populasi penelitian adalah dokumen rekam medis rawat inap bulan Januari-Februari tahun 2025 dengan sampel 75 rekam medis, pengumpulan data dilakukan melalui lembar *checklist*. Data diolah menggunakan analisis univariat.

Hasil

Hasil penelitian menunjukkan kelengkapan pengisian rekam medis review identifikasi pasien mencapai 100%. Namun, kelengkapan laporan penting hanya 83%, dengan komponen yang paling tidak lengkap adalah tanggal keluar (45,30%) dan catatan perkembangan pasien terintegrasi (CPPT) (60%). Rata-rata kelengkapan autentikasi adalah 77,35%, dan pencatatan yang benar mencapai 99,57%.

Kesimpulan

Pengisian rekam medis pasien rawat inap di Rumah Sakit Universitas Andalas termasuk lengkap, meskipun masih ditemukan sejumlah ketidaklengkapan dalam pengisian. Temuan ini mengindikasikan perlunya peningkatan kompetensi tenaga medis melalui pelatihan yang berkesinambungan, guna memastikan kelengkapan dokumentasi rekam medis serta mendukung peningkatan mutu pelayanan kesehatan.

**ANALYSIS OF THE COMPLETENESS OF INPATIENT MEDICAL
RECORDS FILLING AT ANDALAS UNIVERSITY HOSPITAL IN 2025**

ABSTRACT

Research Objective

This study aims to analyze the completeness of inpatient medical records at Andalas University Hospital in 2025. The analysis focuses on the percentage of completeness based on four main aspects, namely patient identification, important reports, authentication, and accuracy of recording.

Methodology

This study employs a quantitative descriptive method. The study population consists of inpatient medical records from January to February 2025, with a sample size of 75 medical records. Data collection was conducted using a checklist. Data analysis was performed using univariate analysis.

Results

The study results indicate that the completeness of patient identification in medical records reached 100%. However, the completeness of important reports was only 83%, with the least complete components being the discharge date (45.30%) and the integrated patient progress notes (CPPT) (60%). The average completeness of authentication was 77.35%, and accurate documentation reached 99.57%.

Conclusion

The completion of medical records for inpatients at Andalas University Hospital is relatively complete, although some incompleteness was still found in the completion. This finding indicates the need to improve the competence of medical personnel through continuous training to ensure the completeness of medical record documentation and support the improvement of health service quality.
