
**ABSTRAK**

Perkembangan teknologi telah mengubah bentuk praktik perjudian dari yang semula dilakukan secara konvensional menjadi berbasis digital, sehingga melahirkan fenomena judi *online* yang semakin mudah diakses, meluas, dan sulit dikendalikan. Kecanduan terhadap judi *online* memberikan dampak serius terhadap hubungan antara suami dan istri. Judi *online* tidak hanya memengaruhi aspek ekonomi keluarga, tetapi juga mengganggu keharmonisan rumah tangga hingga berujung pada perceraian. Rumusan masalah yang akan dibahas didalam penelitian ini yaitu : 1. Bagaimana pertimbangan hakim dalam memutus perceraian yang disebabkan oleh judi *online* di Pengadilan Agama Sungai Penuh? 2 Apa upaya Kementerian Agama dalam mengurangi angka perceraian akibat judi *online*?. Penelitian ini menggunakan metode kualitatif dengan pendekatan yuridis normatif. Teknik analisis data dilakukan secara deskriptif-analitis. Hasil penelitian menunjukkan bahwa: 1. Pertimbangan hakim dalam memutus perceraian karena judi *online* merujuk pada Pasal 19 huruf (f) Peraturan Pemerintah Nomor 9 Tahun 1975 dan Pasal 116 huruf (f) Kompilasi Hukum Islam, yang mengatur perceraian akibat perselisihan terus-menerus. Dalil “pertengkaran terus-menerus” lebih sering digunakan sebagai alasan perceraian, sementara penyebab seperti judi *online* ditempatkan dalam bagian pertimbangan. 2. Kementerian Agama memainkan peran sentral dalam menekan angka perceraian akibat judi *online* melalui pendekatan edukatif, spiritual, sosial, dan kolaboratif melalui beberapa program seperti Bimbingan Perkawinan, Keluarga Sakinah, Tepuk Sakinah, serta peran aktif penyuluh agama.


**ABSTRACT**

Technological developments have changed conventional gambling practices into digital-based forms, leading to the rise of online gambling which is more widely accessible and much harder to control. Furthermore, gambling addiction has a serious, negative impact on husband-wife relationships. Not only does online gambling worsen the economic condition of a family but it also provokes marital disputes, which frequently end in divorce. This research was aimed at answering these questions: 1. What are the rationales behind the judicial considerations on divorce at Sungai Penuh religious courts? 2. What measures does the Ministry of Religious Affairs take to reduce the number of divorces caused by online gambling? This qualitative research adopted a normative juridical approach. Moreover, the descriptive analytical technique was used in the data analysis. The research found that: 1. The judge's reasoning in divorces due to online gambling was based on Article 19 letter (f) of Government Regulation Number 9 of 1975 and Article 116 letter (f) of the Compilation of Islamic Law, governing divorces due to continuing disputes. The argument of prolonged marital conflicts was often used as the legal ground of divorces, while the cause of disputes like online gambling was taken into the judge's consideration. 2. The Ministry of Religious Affairs played a pivotal role in limiting the rates of divorces due to online gambling through educational, spiritual, and social approaches as well as organizing collaborative programs like the Marriage Guidance program, the *Sakinah* Family program, and the *Tepuk Sakinah* program, supported by the active role of religious counselors.
