### CONCLUSIONS & SUGGESTIONS

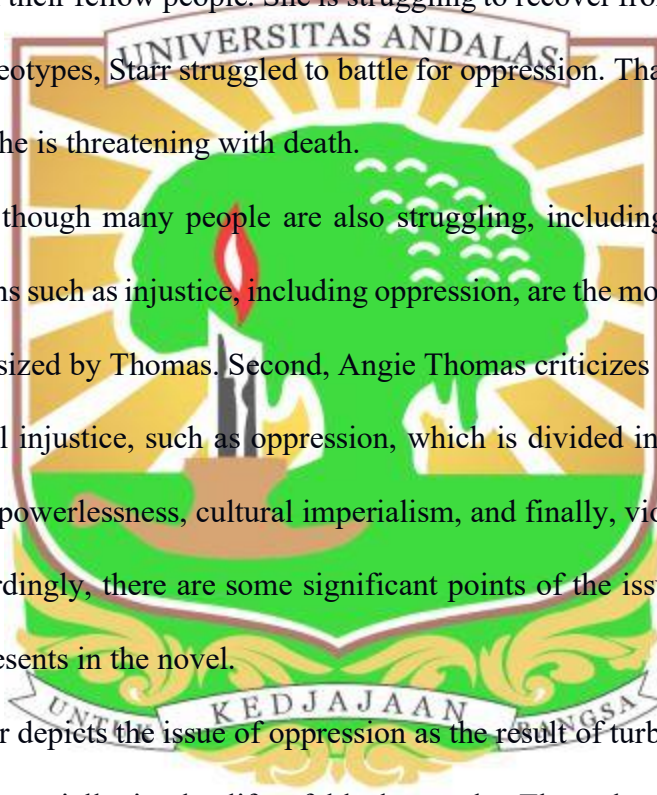
#### 4.1. Conclusion

In *The Hate U Give*, Angie Thomas addresses the issue of oppression, as presented in the novel. Thomas reveals the oppression among black people. The characters in the novel, especially Starr, as the major character, struggle to the oppression of their fellow people. She is struggling to recover from fear and mourning. To avoid stereotypes, Starr struggled to battle for oppression. That is not quite easy for her because she is threatening with death.

Even though many people are also struggling, including family and friends. First, problems such as injustice, including oppression, are the most common important views emphasized by Thomas. Second, Angie Thomas criticizes social conditions that express social injustice, such as oppression, which is divided into five parts, namely exploitation, powerlessness, cultural imperialism, and finally, violence.

Accordingly, there are some significant points of the issue of oppression that Thomas represents in the novel.

First, Salinger depicts the issue of oppression as the result of turbulent times in human experience, especially in the life of black people. Throughout the story, Thomas implies that black people who are experiencing turmoil feelings, such as; sadness, fury, disappointment, grief, eventually place themselves in a state of oppression as a mark of defensive attitude. In other words, Thomas delineates that oppression is a form of the boundary of an individual towards other people.

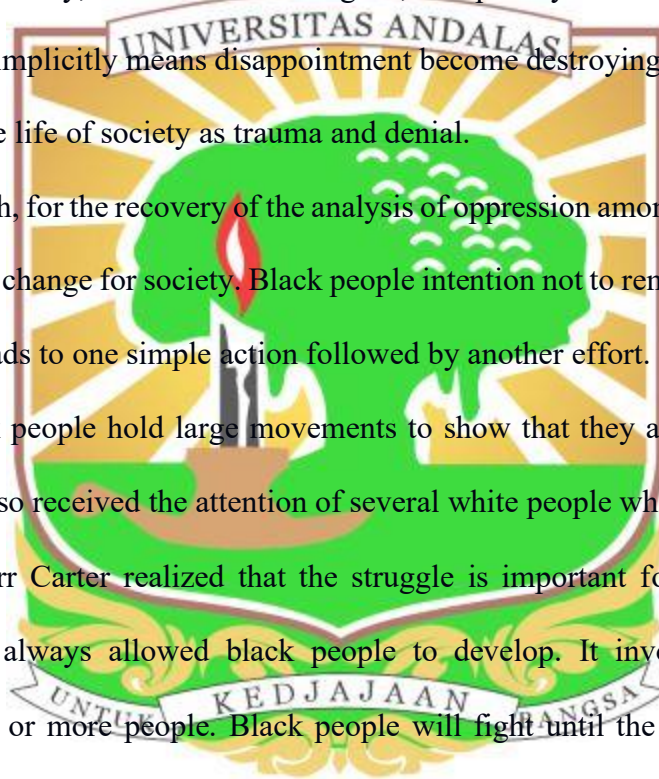


Second, Thomas portrays that the issue of oppression has some influences on the person who emotionally unstable. Thomas addresses that oppression has an important part in influencing the development of one's personality which emerges particular behaviour. Also, Thomas implicitly depicts that oppression creates an unsteady mind or dilemma of a person.

Third, Thomas suggests that there are two main causes of being in a state of oppression, namely, suffer from loss or grief, it implicitly means death and unfulfilled expectation, implicitly means disappointment become destroying.
