He avoids any kind of social commitment and avoids any kind of social interactions.

The main character goes through several unpleasant experiences when he tries to interact with other people. It is because the main character having some problems in engages with his surroundings. Later, the main character chooses to isolate himself from society. He distances himself from people around and lives in his shabby apartment for the rest of his life. This event is caused by the effect of society's treatment towards the main character. Finally, he isolates himself from his environment into the underground world and distances himself from society. The Underground Man cannot find a way to fit in among his community. He has given up upon his society to make an interaction and to face a stranger out there. The Underground Man indirectly withdraws from social interaction because he does not belong to any group.
