**ABSTRAK**

Covid-19 merupakan bencana non alam yang telah ditetapkan sebagai pandemi global oleh WHO pada tanggal 11 Maret 2020. Upaya pencegahan penyebaran COVID-19 telah dilakukan oleh Pemerintah RI namun kasus COVID-19 semakin meningkat. Masyarakat merupakan indikator penting dalam upaya pencegahan COVID-19 sehingga perilaku masyarakat dalam upaya pencegahan penularan COVID-19 sangat signifikan terhadap penanganan COVID-19. Penelitian ini merupakan penelitian kualitatif dengan pendekatan studi kasus yang bertujuan untuk mendeskripsikan dan menginterpretasikan mengenai perilaku masyarakat terhadap pencegahan COVID-19. Empat orang partisipan diambil dengan menggunakan teknik *purposive sampling* untuk berpartisipasi dalam proses wawancara semi terstruktur. Hasil wawancara ditranskrip secara verbatim dan diolah dimana dihasilkan 3 tema utama, yaitu (1) penerapan perilaku pencegahan COVID-19; (2) variasi penyebab ketidakpatuhan penerapan perilaku pencegahan COVID-19; (3) harapan terkait perilaku pencegahan COVID-19. Diharapkan kepada pelayanan kesehatan agar lebih memaksimalkan peran dan memberikan informasi dan edukasi terkait perilaku pencegahan penularan COVID-19.

**CASE STUDY: BEHAVIOR PREVENTION OF COVID-19 IN THE  
COMMUNITY AT RW.08 KELURAHAN PASIE NAN TIGO**

**ABSTRACT**

*Covid-19 is a non-natural disaster that has been designated as a global pandemic by WHO on March 11, 2020. Efforts to prevent the spread of COVID-19 have been carried out by the Government of Indonesia, but cases of COVID-19 are increasing. The community is an important indicator in efforts to prevent COVID-19 so that people's behavior in an effort to prevent the transmission of COVID-19 is very significant in handling COVID-19. This research is a qualitative research with a case study approach that aims to describe and interpret the behavior of the community towards the prevention of COVID-19. Four participants were taken using purposive sampling technique to participate in the semi-structured interview process. The results of the interviews were transcribed verbatim and processed which resulted in 3 main themes, namely (1) the application of COVID-19 prevention behavior; (2) variations in the causes of non-compliance with the application of COVID-19 prevention behavior; (3) expectations regarding COVID-19 prevention behavior. It is hoped that health services will maximize their role and provide information and education related to the behavior of preventing the transmission of COVID-19.*
